

# Orton Waterville Parish Council Assets Inventory

With the publication of an assets list the recommendations are that the following information is shown: description, location and sizes, ownership or custodian, date and cost of acquisition and present use. In the following list the description, location (map reference – degrees, minutes, seconds), approximate size and ownership are shown. The use is evident from the description. The cost of acquisition is generally £0 as most assets of note have been ‘inherited’ by or gifted to the council. We will respond to anyone with a specific enquiry regarding costs and dates of acquisition.

The following is a list of the assets that Orton Waterville Parish Council is responsible for as of 1st January 2018:

## 1. Common Land registered to Orton Waterville Parish Council

- Play Area at The Gannocks (area between Wyman Way and The Gannocks) – location 52-33- 04N, 0-17-35W – size 1.80 acres or 7284.34 Sq.m. Commons Registration no. CL79 dated 26<sup>th</sup> June 1970.
- Parish Allotment in area between Wyman way and The Gannocks – location 52-13-14N, 0-17-40W – size 1.30 acres or 5260.91 Sq.m. Commons Registration no. CL77 dated 26<sup>th</sup> June 1970.
- Village Green – location 52-33-02N, 0-17-52W – size 0.15 acres or 607.03 Sq.m. Commons Registration no. CL78 dated 26<sup>th</sup> June 1970.
- Grassed ‘Triangle’ at corner of Cherry Orton Road and New Road – location 52-37-57N, 0-17-52W – size 0.02 acres or 80.04 Sq.m. Commons Registration no. CL76 dated 26<sup>th</sup> June 1970.

## 2. Owned Land

- Allotments, and infrastructure, off Cherry Orton Road – location 52-33-05N, 0-17-54W – size 5,000 Sq.m.
- Burial ground and all infrastructures within – location 52-33-05N, 0-17-44W – size 3,200 Sq.m.

## 3. Owned Infrastructure

- Bus shelter in lay-by on Oundle Road opposite junction with Cherry Orton Road – location 52-13-18N, 0-17-40W.

- Eight Seats – the ‘Jean Barker memorial’ seat (outside burial ground), the ‘Hildegard Hall memorial’ seat (inside the burial ground), seat outside Plegan Place play area, seat inside Plegan Place play area, seat at junction of Cherry Orton Road and Oundle Road, seat at junction of Cherry Orton Road and Chapel Lane, seat at junction of Cherry Orton Road and Church Drive, seat to side of Brimbles Way opposite Matley.
- Equipment in the Play Area on the Common Land at The Gannocks.
- War Memorial in St Mary’s churchyard – location 52-33-02N, 0-17-46W.
- Noticeboards around the parish in Church Drive, Matley, Napier Place, Orton Northgate, Orton Centre Co-operative Store and at Village Hall.
- Orton Waterville village sign and structure and Jubilee plaque – location 52-33-17N, 0-17-41W.
- Two finger post signs: to ‘Village Hall’ at junction of Cherry Orton Road and Glebe Avenue, to ‘Chapel’ at junction of Cherry Orton Road and Chapel Lane.
- Office equipment (Computer, printer, filing cabinets, etc.).

#### **4. Village Hall**

- Orton Waterville Parish Council is the holding trustee of the Village Hall charity. Orton Waterville Village Hall is located at the end of Glebe Avenue – location 52-32-57N, 0-18-00W.

#### **5. Maintained Land**

- Orton Waterville Parish Council is the administrator of the allotments at Gostwick in Orton Brimbles – location 52-33-01N, 0-18-32W – size 8,700 Sq.m.
